DISPLAY FIREWORKS PERMIT APPLICATION

All requested information on this form must be complete and legible.

Permit applications must be received at least 30 DAYS in advance of the date of proposed use.

“Display Fireworks”

- The term “display fireworks” shall be defined as provided in Section 2401 of Act 43 of 2017 as large fireworks to be used solely by professional pyrotechnicians and designed primarily to produce visible or audible effects by combustion, deflagration, or detonation. The term includes, but is not limited to: 1) Salutes that contain more than two grains or 130 milligrams of explosive materials; 2) Aerial shells containing more than 60 grams of pyrotechnic compositions; and 3) Other display pieces that exceed the limits of explosive materials for classification as consumer fireworks and are classified as fireworks UN0333, UN0334, and UN0335 under 49 CFR 172.101 (relating to purpose and use of hazardous materials table).

1. Fee: See the Township's Fees Resolution for current fee. Payment may be made via cash or check made payable to Freedom Township.
2. Copy of the approved Uniform Construction Code (UCC) fireworks permit from PA Municipal Code Alliance.

3. Copies of all federal, state, and local permits and/or licenses needed for the use of display fireworks.
4. Written documentation that the operator has all necessary federal licenses and authorizations to possess, store, and use display fireworks.
5. A bond or proof of liability insurance of no less than \$1,000,000 for the payment of any and all damage caused to any person(s) and property by reason of the display and arising from any acts of the permittee or the permittee's agents, employees, subcontractors, or volunteers. Freedom Township must be the certificate holder and additional insured.

Please note: No display fireworks shall be ignited within 300 feet of a permanent or temporary fireworks facility licensed by the PA Department of Agriculture. No permit shall be issued to a business entity which performs, provides, or supervises the use of fireworks for profit unless it provides proof of registration with the PA Attorney General.
