### Call to Order

Chair Young called the Board of Supervisor's Meeting to order at 7:00 P.M.

#### **Public Comment**

Ms. Mumaw-Powell asked for the Township to provide PennDOT a letter requesting a sign be added near 3210 Emmitsburg Road stating "school bus stop ahead". She stated she is concerned with speeders potentially hitting children during school pickup/drop-off.

# **EMS, Fire, & Police Reports**

Adams Regional Emergency Medical Service (AREMS) did not submit the monthly report.

Mr. Milligan presented the fire report. Greenmount Fire Department had 7 calls in the month of April:

- 2 traffic accidents. 1 in Freedom Township & 1 in Emmitsburg, MD.
- 1 utility wires with fire in Cumberland Township.
- 1 residential fire in Carroll County, MD.
- 1 vehicle fire in Freedom Township.
- 1 water rescue in Freedom Township.
- 1 transfer to Washington Township.

Ms. Hansen presented the police report. Liberty Township Police worked 25 hours in the month of March. There were three 911 calls, 50 traffic citations, and 17 written warnings.

She stated they will run speed in the Emmitsburg Road area where a sign is being proposed, and will provide the data to Mr. Gulden to add to the PennDOT letter requesting a school bus ahead sign.

Vice-Chair Kellett made a **MOTION** to approve a special event permit for the Gettysburg National 19<sup>th</sup> Century Baseball Festival for July 16 & 17, 2022 and waive the traffic control requirements. The **MOTION** was **SECONDED** by Chair Young. The motion carried unanimously (3-0).

#### C. Garage addition discussion.

Mr. Gulden stated he researched firms and Lobar Associates was the winning bidder in the Keystone Purchasing Network for design/civil engineering, general construction, electric, plumbing, & HVAC.

The Board agreed that the garage addition should be approximately 30' x 40' with the possibility of including HVAC. They directed Mr. Gulden to reach out to Lobar Associates & Morton Buildings for a meeting to discuss the project.
