Call to Order

B. Discussion of stormwater ordinance amendment.

Mr. Gulden stated that the Township's stormwater engineer, KPI Technology, has suggested an amendment to the stormwater ordinance. The amendment would add definitions of "Access Drive" and "Driveway" and update the definition of "Impervious Surface (Impervious Area)." The purpose of the amendment is to consider "wagon wheel" access drives/driveways fully impervious.

The Board supported the amendment only for access drives/driveway from the road to the dwelling / main structure.

Vice-Chair Kellett made a **MOTION** to approve an advertisement of the stormwater amendment for adoption at November's regular meetin. The **MOTION** was **SECONDED** by Mr. Johnston. The motion carried unanimously (3-0).
