- A. Timothy P. Shields & Tamera R. Shields Preliminary / Final Subdivision Plan.
 - Recommend <u>approval/denial</u> of waiving §303 of the Subdivision and Land Development Ordinance (SALDO), submission of separate preliminary plan, for consideration.

Chair Belt made a **MOTION** to recommend approval of waiving §303 of the SALDO. The **MOTION** was **SECONDED** by Secretary Buchheit. The motion carried unanimously (3-0).

b. Recommend <u>approval/denial</u> of waiving §304.A.28. of the SALDO, showing drainage features, for consideration.

- 1. The plan shall state the density calculations for the property (605.A.);
- 2. The height regulations shall be included in the site data (605.D.);
- 3. All preliminary plan requirements shall be met with the final plan submission (303);
- 4. The distance and bearings for the entire Shields property should be shown on the plan (304.A.10.);

- 5. A street monument shall be set along a common property line at the street right-of-way line (304.A.18);
- 6. Sewage facilities planning approval is required (304.B.1);
- 7. A Township driveway permit may be needed for the additional dwelling (405.B.4);
- 8. An executed owner's acknowledgement is required;
- 9. Adams County Office of Planning and Development comments should be received, reviewed, and considered.

The **MOTION** was **SECONDED** by Secretary Buchheit. The motion carried unanimously (3-0).
