#### **Call to Order**

Chair Young called the Board of Supervisor's Meeting to order at 7:08 PM and announced that the Board of Supervisors held an executive session with Liberty Township Supervisors on October 30th regarding personnel.

#### **Public Comment**

Ms. Kipp, representing the Land Conservancy of Adams County, requested the Township donate \$5,000.00 in 2026 towards the preservation of 56 acres owned by Doug and Jane Sentz on Schriver and Red Rock Roads.

Ms. Calhoun requested the Board support the Land Conservancy's request.

#### **Approval of Minutes**

Vice-Chair Kellett made a **MOTION** to approve the regular meeting and public hearing minutes of October 15, 2025. The **MOTION** was **SECONDED** by Mr. Johnston. The motion carried unanimously (3-0).

#### **Monthly Expenses**

Vice-Chair Kellett made a **MOTION** to approve the bills for October in the amount of \$11,598.66 from the General Fund, \$514.00 from the Escrow Account, and \$2,083.33 from the Fire Tax Fund. The **MOTION** was **SECONDED** by Mr. Johnston. The motion carried unanimously (3-0).
